## Photo ID law effective for November 5, 2013 Election

Voters will be required to show proof of identification to cast a ballot in the upcoming November 5, 2013 Constitutional Amendment Election/Cuero ISD Bond Election/Yoakum ISD Bond Election.

A voter will be required to show one of seven forms of photo identification at the polling location before the voter will be permitted to cast a vote. The acceptable forms of identification include:

- 1. Texas driver license issued by the Texas Department of Public Safety (DPS)
- 2. Texas Election Identification Certificate issued by DPS
- 3. Texas personal identification card issued by DPS
- 4. Texas concealed handgun license issued by DPS
- 5. U. S. military identification card containing the person's photograph
- 6. U. S. citizenship certificate containing the person's photograph
- 7. U. S. passport

With the exception of the U.S. citizenship certificate, the identification must be current or have expired no more than 60 days before being presented at the polling place.

## This new photo ID requirement does not apply to voters casting a ballot by mail; it is only for voters casting a ballot in person.

Voters are encouraged to update their voter registration certificates to *exactly* match the name on the photo ID they plan to use at the polls. Voters may use a photo ID that does not exactly match the name on their voter registration certificate if the names are *substantially similar* but the voter will have to initial an affidavit stating they are the same person. If the voter's name on the voter registration certificate and the voter's photo ID are neither identical nor substantially similar, the voter will need to vote provisionally. Therefore it is recommended that voters check the name on their voter registration certificate, and update their registration as necessary no later than 30 days prior to an election in which the voter will vote. For the November 5, 2013 election, all updates to voter registration certificates must be completed no later than Monday, October 7.

To compare the voter's name on the voter registration certificate to their photo ID, voters may use the "Am I Registered?" feature at <u>www.votetexas.gov</u>.

Election identification certificates are now available only for voters who do not already have a required form of photo identification. There is no fee for the certificate. Please be reminded, the new photo ID law does NOT apply to ballot by mail voters.

Voters are strongly encouraged to please prepare now for the new photo ID requirements in an effort to make sure that voting goes smoothly for the November 5, 2013 election.
