The student must maintain 95% attendance and passing grades in all classes and assessments (including STAAR).

The student must adhere to the Nordheim ISD Student Code of Conduct at all times. One incident warranting ISS or higher results in a parent conference. A second incident may result in immediate revocation of transfer. DAEP or expellable offenses will result in immediate removal.

Parental involvement is expected and may include volunteering at events, assisting with school programs, and supporting student activities.

Bus privileges may be revoked for misconduct.

Transfer status is subject to review each semester. Transfers can be revoked at the discretion of the superintendent based on violations of this agreement.

If revoked or voluntarily withdrawn, students may be ineligible for future transfer.

Students who move out of the district must immediately reapply for transfer consideration. Failure to do so may result in removal from enrollment.
